# Community Leadership Scholarship

Leadership for community and economic development results from education, experience and a commitment to work toward a vision. The Community Leadership Scholarship seeks to support and honor Grand Valley State University students who have demonstrated their willingness to combine community service with the pursuit of their professional vocations through a one-time \$1,000 scholarship. This award supports those students who pursue entrepreneurism to improve quality of life. This scholarship benefits students who major in any field, with a preference for those who major in business or public and nonprofit administration. The scholarship was established by the founding members of the Grand Valley University Foundation Leadership Committee, who seek to advance new generations of business leaders and community philanthropists.

#### Application Criteria:

- 1. Recipients must be entering their junior or senior undergraduate year at Grand Valley State University.
- 2. Candidates must give evidence of significant community service performed while a college student at Grand Valley State University and give expression to their desire to be engaged in community service throughout their lives, either through their professions or as volunteers, board members and so forth.
- 3. Recipients must be enrolled with full-time status as a degree-seeking student at Grand Valley State University.
- 4. Candidates shall be making satisfactory academic progress according to the norms established by the University.
- 5. Demonstration of financial need is not required.

Application packets are available in the Seidman Undergraduate Student Services office (101B DEV), and are due to the American Humanics Nonprofit Leadership Program office, 228C DeVos Center, Grand Valley State University, Grand Rapids, MI, 49504, no later than **April 3, 2009**.

### Write It - Then Cite It!

Finishing a paper involves making sure you are giving credit where credit is due to ideas and quotes from other sources you discovered in your research process. Citations can add value to your paper. Of course you want to give your own analysis and thinking on your topic, but when you give someone else's opinion, you need to acknowledge that source. Finding information online does not mean it is general knowledge and does not need a citation. The purpose of citing sources is to allow your reader to easily locate your research source. Library Guides (<a href="http://libguides.gvsu.edu/home">http://libguides.gvsu.edu/home</a>) can assist you in this process of citing sources correctly and preparing a bibliography.

First find out what style manual your instructor wants you to use. For Seidman College graduate courses, APA Style is preferred. The Library has prepared a Library Guide on Citing Sources. Other Library Guides that include recommended sites for learning more about citations and bibliographies are: Accounting, Taxation and Finance; Business; Company & Industry Research; Economics; International Business/Country Research.

All of the university libraries have style manuals at the reference desk for your use. Another library guide you may want to consult is Plagiarism. This guide helps you determine what plagiarism is and what does not constitute plagiarism. Did you know anything that is viewable or hearable format must be credited to the source and in many cases permission must be secured to use these images, photos, artwork, recording, etc.? Keep this in mind when you are preparing your paper or presentation.

Many of the databases such as ABI/Inform Global or Business Source Complete offer you an option to "cite this source" when you locate an article. Sounds good, but BE careful. Not every database cites correctly. You need to know enough about your citation style to recognize when something is not right. Have you used the citation program Knight Cite designed by students at Calvin College? It is a program that can cite books, articles, and online sources in MLA, APA or Chicago style. You fill in the blanks, hit submit and get a citation for your bibliography. Unfortunately, this program does not differentiate between the 3 styles when it comes to capitalization. You have to know whether every word in an article or book title is capitalized or just the first word needs capitalization. You must enter it correctly when you fill out the form. When using citations from databases, watch the capitalization and also how the authors are listed. Know your style format to make sure the citation you are given is a match or if you need to make adjustments.

Citing your sources is an important part of your paper. It takes time and can be frustrating until you understand the style you are working with. Use the help available to you through the manuals of style, specific websites for formatting citations, or consultations in the Writing Center.
