## Gift from ooVoo.com for GVSU Community

GVSU was given a gift by a video chat service called ooVoo.com. The gift is a free one-year business subscription to all members of the Grand Valley State University community. The business plan allows you options such as: 6-way video chat windows, desktop sharing, file sending, instant chat, sending videos in your emails, recording your conversations and any more features.

ooVoo is using Grand Valley State University as one of its two lab schools. The other lab school is the University of Georgia at Athens (UGA). Please feel free to download the program at <a href="www.gvsu.edu/ooVoo/">www.gvsu.edu/ooVoo/</a>. The company is also working with the University of Texas at El Paso (UTEP).

There are two things to remember with ooVoo. First, it is a higher quality video resolution than many video chats so you need fast broadband for it to work properly. Second, if you are using more than two windows, you should use a headset. The library has laptops with ooVoo so that you may use it at school if you do not have a computer.

The library will also soon be providing classes on telepresence (video chat) etiquette. You might not think this is important, but many employers are now using telepresence to interview candidates and these classes will help you prepare for such a potential interview.

Some professors are now using ooVoo for virtual office hours and weekly reviews. This saves everyone gas and time. You should give it a try! If you have any problems, contact ooVoo support or email ooVoo@gvsu.edu.

# Is That What You Meant to Say?



How do you express yourself in the language of graphics? Frequently, it is important to show data in a chart, table or other form of visual presentation. To be effective in communicating in a graphic form, many options come into play. How the information is displayed can impact the interpretation of the reader. First, you need to determine the best way to show your data. Additional decisions involve use of color, type font, and scale.

Dona Wong, an expert in financial graphics, has written a very timely book, *The Wall Street Journal Guide to Information Graphics: The Do's and Don'ts of Presenting Data, Facts, and Figures.* In this book, she provides a series of mini-workshops with numerous illustrations to show what works and what doesn't to make meaningful graphics for a paper or presentation.

Start with the "three essential elements of information graphics:" rich content, inviting visualization and sophisticated execution. According to Wong, "Rich content brings meaning to a graphic. Inviting visualization interprets the content and highlights the essence of the information for the reader. Sophisticated execution brings the content and graphics to life."

Using this guide, it is easy to see where and how graphics add power and clarity to sharing data. Find this book at the Steelcase Library.
