L. V. Eberhard Scholarship - Incoming Freshmen

The L. V. Eberhard Business Scholarship provides a distinguished scholarship award to entering undergraduate students in the business program.

The scholarship requires students to have a minimum high school grade point average of 3.5 and a minimum 29 ACT composite score. The scholarship amount is \$1,000 and is renewable for four years.

The Seidman College of Business is proud that Thomas Hakim, a double major in finance and international business, was this year's recipient of the Seidman Service Award. This award honors students for their outstanding service to Seidman, the university, and the community.

While maintaining outstanding grades, Tommy has studied abroad in Guadalajara, Mexico, acted as an ambassador for study abroad to other students, served as a student ambassador for Admissions for nearly three years, was a Volunteer and Leadership Staff Assistant for the Office of Student Life for one year, has participated in Seidman IPO (Investment Portfolio Organization) for three years, was the 2004/2005 President of Seidman IPO, and was one of the students invited to serve in Seidman's Strategic Planning Initiative.

In addition to assisting the university, Tommy has also made time for working with numerous community agencies and charitable organizations, not the least of which was conducting three sessions for Junior Achievement, including one in Spanish, and helping to organize Seidman student participation in the American Cancer Society – Relay for Life.

American Production and Inventory Control Society (APICS) Scholarship

APICS scholarships are given annually to students interested in production and inventory control. The students are selected based on scholarship and financial need. The Grand Rapids Chapter of APICS provides the \$500 awards. This year's winners are Michael Stewart, Nathan Grzybowski, and David Johnson.

Building Owners and Managers Association (BOMA) of Grand Rapids Scholarship

Every year, BOMA awards a \$1,000 scholarship to a Seidman junior with a 3.0 or higher GPA and either a major in real estate economics or an interest in real estate. The 2004-2005 recipient is **Albert Robison**. Albert is majoring in business economics with a real estate emphasis.

Delta Sigma Pi Scholarship Key

Each year, Delta Sigma Pi, a co-educational, interdisciplinary business fraternity, awards the Delta Sigma Pi Scholarship Key to the graduating Seidman senior achieving the highest level of scholarship. Beta Gamma Sigma Awards

Only the best business students in the world, and professionals who earn the distinction of "The Best in Business" during their academic careers, can claim membership in Beta Gamma Sigma, the honor society serving business programs accredited by AACSB International. While almost 300,000 students receive bachelors or master's degrees in business each year, only about 20,000 are inducted into lifetime membership in Beta Gamma Sigma.

Induction to Beta Gamma Sigma is offered once each year to the top 7% of juniors, 10% of seniors, and 20% of graduate students in business. Membership benefits include access to the BetaLink online community, the opportunity to participate in Alumni Network activities, and lifelong recognition for outstanding academic achievement.

The Seidman College of Business is pleased to present Professor **Barry Castro**, management, as this year's winner of the Seidman Faculty Service award. Dr. Castro began his service at GVSU in 1973. He initially was a professor in the William James College, one of the GVSU cluster colleges, and joined the Seidman College of Business as a management faculty member in the early 1980s.

Dr. Castro's commitment to teaching and scholarly work, his service as Assistant Dean for a period, and his development and nurturing of the Ethics Center have greatly served students and enhanced Seidman's reputation in the community.

Faculty Focus
