Summary

Crossroads Charter Academy exists to cultivate a community of lifelong learners with courage, resolve, and strength of character. The academy has been serving students in the Big Rapids area since the start of the 1998-1999 school year. The district consists of two buildings; the elementary building serves students in kindergarten through fifth grade, and the secondary building serves students in grades 6-12.

Highlights

The academy is implementing Project Based Learning (PBL) with community interaction and support.

The academy is implementing a data-driven MTSS model for instruction across grades.

The academy has a comprehensive SEL curriculum with an onsite, full-time social worker.

CSO Capacity Analysis

Crossroads Charter Academy has completed the first year of a 3-year charter term with mixed results. The CSO has observed that Project Based Learning continues to engage students and staff in some grades but requires greater investment to achieve fidelity in all grades. The decline in enrollment continues to challenge the academy's organization to address its core mission. The CSO is encouraged that a plan is in place to regain the academy's footing in the local community. The academy has new leadership in place that is taking an aggressive approach to meeting the conditions of the charter contract. Overall, the CSO is confident that the academy leadership and board understand improved academic performance must be evidenced at the end of the 23-24 academic year in order to remain a viable educational option for students and families.


