FINANCIAL VERIFICATION PROCESS gysu.edu/admissions/internationaladmits

Now that you have been admitted to Grand Valley, your next step is to get your I-20. To get your I-20, you will need to complete a financial verification form and submit your passport and financial documents in your **Laker Portal.** You can also upload information for any dependents who will be joining you. Your financial verification documents must show that you have enough financial support to cover the estimated costs of academic and living expenses for one academic year. You will also receive an email with instructions to complete this process.

VISA APPOINTMENT

Check Documents

Before applying for your visa, you must make sure all of the documents sent to you by Grand Valley are correct. Pay special attention to the spelling of your name, date of birth, major, and funding source.

SEVIS Fee

The SEVIS fee is a required payment imposed by the U.S. government for students attending Grand Valley on an F or J visa. This fee must be paid before the visa appointment. The SEVIS fees are as follows:

- F Visa: \$350
- J Visa: \$220

You can pay your SEVIS fee online at **FMJFee.com** or through Western Union.

*International students with visa types other than F-1 and J-1 do not need to complete these steps.

Visa Appointment

Once you have the receipt for your SEVIS fee, you should visit the U.S. Embassy website in your country and apply for a visa appointment.

HOUSING

It is recommended that you apply for housing and submit your housing deposit as soon as possible.

When living on campus, all living expenses are included in the rate; you manage one consolidated bill. Students enjoy living on campus because of the convenience to dining, classrooms, study areas, and recreation spaces. Important Information

- First-year international students are required to live on campus.
- Undergraduate transfer students and graduate students are not required to live on campus.
- Complete an online application at gvsu.edu/housing.
- Students are only eligible for a housing assignment if they have submitted a housing deposit and have completed a housing application and contract.

REGISTER FOR COURSES

✓ Sign up for orientation

UNDERGRADUATE STUDENTS gvsu.edu/orientation

After being admitted, and before arriving in the U.S., you will receive details on how to sign up for a New Student Orientation session where you will collaborate with an academic advisor to choose your courses. This session is an opportunity to ask questions about your study program, class schedule, graduation requirements, and any other academic concerns. Following your appointment, you will be enrolled in 12 to 15 credits per semester. Once you arrive on campus, you'll also attend International Student Orientation hosted by International Student Services

✓ Provide Final Transcripts

High School

It is important that you send an official or attested final transcript and graduation certification that includes your date of graduation.

Other Colleges Attended

To receive transfer credit at GVSU for courses completed at another college, you must send your official college transcript along with course descriptions and syllabi translated into English to GVSU.

REGULATIONS

Full-time enrollment

In compliance with the U.S. Citizenship and Immigration Services (USCIS), undergraduate international students are required to carry no fewer than 12 credits each semester and have two semesters to achieve a 2.0 GPA. Graduate international students are required to carry no fewer than 9 credits each semester and have one semester to achieve the appropriate GPA. For that reason, students must have the written approval of the director of international student and scholar services before adding, dropping, or changing classes. Failure to meet these guidelines may result in dismissal from Grand Valley State University and the USCIS will be notified that the student is out of status.

Change of Address

United States immigration law requires the reporting of a change of address within 10 days of the move, even if it is changing apartments within the same complex.

Travel Signature

Students wishing to leave the U.S. for either travel or vacation must have their status verified by the designated school office. For more information about the status verification process, visit **gvsu.edu/istudents/request**.

Network ID

As a GVSU student, you'll use a Network ID and password for access to computer labs, email, Banner, multifactor authentication, and more. Instructions to activate your username and password will be emailed to you and available in your Laker Portal.

GVSU Email

Grand Valley provides a free Gmail account through Google Apps for Education. This Gmail account will be the official communication method used by the university once you're enrolled in classes. You'll be able to access your GVSU email account by visiting mail.gvsu.edu once you set up your GVSU network account.

Internet Access
