Chair's Report – No report.

Director's Report—The university Digital Literacy group is focused on incorporating digital literacy into the curriculum. Due to general education's broad impact on students, the director might serve on both subcommittees. The committee may survey students in advance to assess their current digital skills. Additionally, the committee may explore whether there's a gap between faculty expectations of student abilities and what students can actually do.

We have a diversity report based on General Education assessment data from 2013-2019, which uses a Point Percentage Gap to analyze differences in learning outcomes across race, gender, first-generation status, and Pell Grant recipients. Our Graduate Assistant is conducting a Chi-Squared analysis to determine if the data is statistically significant. We plan to update the 2013-2019 report and generate a new one for 2019-2024. Since the campus has become more diverse between these periods, we may see some differences in the results.
