

#### Eligibility

Undergraduate: Declared a major, minor or equivalent in the criminal justice or related field; at least 37.5% of credits required (45 credit hours), have a minimum of 4 CJ courses completed, rank no lower than the highest 35% of their class, and have a cumulative grade point average of 3.2.

Graduate: Enrolled in the criminal justice field, have a full-time graduate academic load (9 credits), and have a minimum grade point average of 3.4.


